VENDORS – RULES & REGULATIONS & APPLICATION

The 3rd Annual Taste of Estero will be held on Sunday April 25, 2010 at the Estero Community Park in Estero Florida. The event will be open to the public from 11:00am until 5:00pm. For the following rules and regulations the term 'Presenter' refers to Estero-Gulf Coast Kiwanis and the term 'Participant' refers to a restaurant or vendor who has made application for space at the 2010 Taste of Estero by executing an Application or Sponsorship Agreement Form. The term 'Event' refers to the 2010 Taste of Estero.

1. ASSIGNMENT OF SPACE

Participant space is restricted to one participant per space and the participant may not assign its space or allow any other person, firm, or organization to use any part of such space, for any reason, without express written permission of the Presenter

2. CANCELLATION

No refunds will be issued for any reason. Neither the Presenter, nor any officers, directors, employees, or agents shall have any liability to the Participant by such cancellation or failure to hold the Taste of Estero.

3. SETUP

Participant setup time is from 7:00am until 10:00am on the day of Event. All Participants vehicles must be removed from Estero Community Park by 10:00am. Vehicle access to tents will not be available. **Vendors will need to provide their own power supply for cooking (generators are okay).** Generators will be available for an additional fee and with advance notification.

4. DURATION

All tents must be staffed from 10:30am until 5:00pm

5. BREAK-DOWN

All materials must be removed by 6:00pm. Any materials left in your tent will be thrown away when the Presenter takes down the tents.

6. TENTS

If Participant is using grease or charcoal, a service will be provided for clean-up. In addition, electricity and/or refrigeration space will be provided for Participant upon request and payment on Restaurant/Sponsor application.

7. CODE COMPLIANCE

Participant is required to adhere to all local, state, and federal rules and regulations applicable to its business and the 2010 Taste of Estero event.

8. INSURANCE REQUIREMENTS

Participant must assume responsibility for and agree to indemnify and hold Presenter and its respective officers, employees, directors, and agents harmless from any and all liability or expense, including government charges or fines and attorney's fees, in connection with any and all claims, demands, and causes of action, created by, arising out of, or resulting from Participant installation, removal, and maintenance of space and supplies; Any goods, products, samples, or souvenirs; Participants activities at the Event and occupancy or use of the facility or any part thereof. By executing the Restaurant Application or Sponsorship Agreement Form and this document, Participants warrants that it shall maintain in full force and effect through the dates of the Event comprehensive general liability insurance, with coverage including personal injury, broad form property damage, contractual liability, operations hazard and products liability, in limits of not less than \$1,000,000.00, which insurance specifically covers all Participant activities on or off-site of the facility and related to the Event. Participant must deliver a certificate of insurance to Presenter naming the Presenter and Lee County as additional insured to complete their application. The certificate of insurance is due no later than April 15, 2010.

9. MENU SELECTIONS

All beverages will be sold by the Presenter. Sponsors and Participants are not permitted to provide any beverages including beverage sampling to Taste of Estero attendees. The Presenter reserves sole right to sell/distribute any and all beverages.

10. CLEAN-UP ISSUES

Any Participant that fails to clean-up their individual booth or abide with the Rules and Regulations stated herein, will

Participant will not be allowed to dump grease or any other debris on any street, curbside, or retention pond at any time.
